DS – Recruitment

DS shared recruitment flyers. Also shared techniques to reach out to departments, chiefs, sheriffs, DA's, etc. Ex: Attend county meetings of chiefs or other agency heads.

KCa explained CAPE's past role as vendor at other association conferences. Offered for presidents to assist in this role, if interested.

DS offered to assist in attending local meetings of agency heads.

KCa explained that membership is not about the number of members, but the focus should be on the quality of training and benefit to the members we have.

CAPE can help law enforcement administration understand the benefits of the organization.

CB – Chapter Motivation/Connection

KCe – Chapter Guidelines Distribution of chapter guidelines (for most chapters). All chapters should create or update their guidelines.

KCe – Awards Deadlines POOTY winner to state board by December 15th Chapter presidents will be responsible for notifying the supervisors of POOTY winners.

KCe – Board Terms & Elections Odd years – Chapter boards Even years – State boards All chapters are misaligned in when they start their new positions. Suggestion for all chapter boards to take office at July 1st. Next chapter boards will take office 7-1-23.
